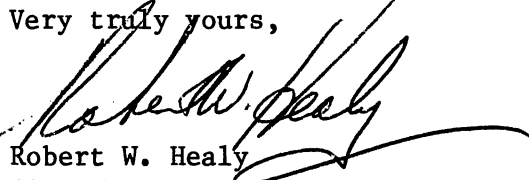

Enclosed please find a request for an appropriation of \$50,000 to the Public Investment Fund for the Community Development Department's Extraordinary Expenditure Account to begin preliminary design work on the Cambridgeport Revitalization District Roadway Improvement Plan. This preliminary work will include finalizing the location of new roads, and finalizing a construction phasing plan for the project.
