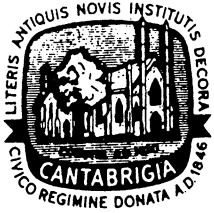

Your application for an amendment, take out window, to your common victualer license at 38 Hampshire Street has been approved by the Board of License Commissioners for ice cream service only.

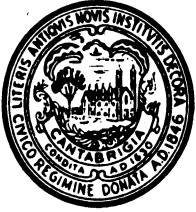
Approvals from the zoning, building, fire and health departments must be received by this office before this license may be issued.
