To The Honorable, The City Council:

I am hereby requesting the appropriation of \$180,000.00 in the FY95 Grant Fund from the Commonwealth of Massachusetts' Executive Office of Communities and Development into Human Services Salary Account (\$107,881.00), Other Ordinary Maintenance Account (\$71,319.00) and Travel and Training Account (\$800.00). This grant is the second year that DHSP has received HIP funding. The program was combined from the Housing Search and the Housing Services Programs that the State had funded for several years. The funds are used to prevent homelessness by providing counseling for tenants, counseling for landlords, mediation for disputes between tenants and landlords and housing search assistance for families facing eviction.
