OUR COMMUNITY IS THREATENED! STOP THE DEMOLITION!

To Our Neighbors,

July 4, 1997

In May, Holmes Realty Trust - owners of the buildings on the corner of Central Square Plaza, running from the CVS all the way around to the Ethiopian Restaurant - announced plans to demolish these four buildings and to build a 11-story monolith which would rise abruptly from the plaza, enclosing some 90 high-priced apartments, 32,000 square feet of high-rent retail, and a 3-story parking garage.

All eleven of the neighborhood shops on the first floor of the existing buildings would be evicted, as would the dentists, accountants, attorneys and other offices on the second floor. The bulldozers would level shops and stores reflecting the diversity of Central Square: Irving's Shoes (in business 75 years), The Golden Donut, Wiener's Tobacco (31 years), Emily Rose (58 years), Lucy Parsons Bookstore, Oriental Buffet, Central Cleaners, A&S Diner, Surman's (in business since 1918!), Anthony's Greek Market, the Ethiopian Restaurant, third generation dentist "Ric" Dana and several more.

This is the heart of Central Square.

This project would not only destroy shops and restaurants upon which we depend - ultimately replacing them with chain stores which can afford to meet developers' high rents - it would also accelerate a spiral of rising rents and evictions throughout the square. Similar plans are already in the works. The environmental impacts — including traffic, fumes and parking — would be devastating.

Central Square must remain a public space where all members of the community feel welcome.

We must act to stop this project and to make it clear to others waiting in the wings that we are determined to defend our community.

- The Holmes Project violates the 'Central Square Action Plan' and Central Square 'Design Guidelines' - city mandates crafted to protect the cultural and economic diversity, affordability, and the character and architectural scale of Central Square.
- The owners cannot build this project without special permits and variances from the Planning Board and the Board of Zoning Appeals! We have the right and the power to block this proposed project. The 'Central Square Advisory Committee' is the first step in a formal review process. Join us at the advisory committee's first formal public hearing, on July 23 at 5:30 pm at the Senior Center, 806 Mass. Ave. (opp. City Hall) Cambridge. Doors open 5:15pm Please Come — Air-Conditioned.
- Any development in Central Square must be a truly democratic process. It must preserve our community and its affordability, and meet the needs of those of us who live and work here. We intend to fight this demolition, oppose any special permits or variances, and demand that the city act to preserve an affordable Central Square!

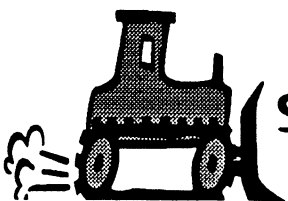
