To The Honorable, The City Council:

I am hereby requesting the appropriation of \$158,400.00 in the Grant Fund of the Department of Human Services Salary & Wages Account \$144,015, Other Ordinary Maintenance Account \$13,685, and Travel & Training Account \$700 from the Massachusetts Department of Housing and Community Development. The Planning and Development Division of Human Services was created when the State combined the Housing Search Program and the Housing Services Program into the Homeless Intercept Program under EOCD. These funds will be used for salaries for staff, program and training costs associated with the prevention of homelessness by providing counseling for tenants and landlords, mediation for disputes between tenants and landlords, and housing search assistance for families facing eviction.
