WHEREAS: In addition to the dangers and inconvenience experienced during the electrical outage which affected about two thirds of Cambridge in the early evening of Saturday, February 11, 1989, that same outage revealed the presence of an outrageous hazard to the health and safety of residents at the Senior Citizen Apartments at 55 Essex Street. In the midst of the outage, due to a malfunctioning emergency generator, no emergency lighting was available to the residents. There is no justification for the fright and fear, the threat to life and limb which this non-working emergency generator imposed on these senior residents; now therefore be it

ORDERED: That the City Manager direct the Commissioner of Inspectional Services to insure that, once and for all, full and not selective enforcement of the city's health and safety code is the order of the day, that insuring the health and safety of every citizen by stringent enforcement of every law takes precedence over politically favored law. The City Manager is directed to request that the Commissioner of Inspectional Services provide this Council with verification of the most recent date, prior to February 11, 1989, on which the emergency generator at 55 Essex Street was inspected and certified as being in good working condition, as well as to provide verification of same for every Senior Citizen Apartment Complex in Cambridge; and be it further

ORDERED: That the City Manager report back to this Council on this matter and with the requested documents on February 27, 1989.
