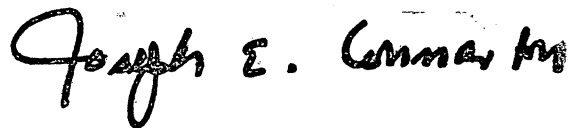

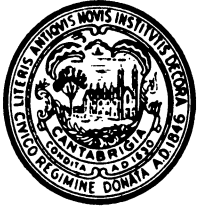

To the Honorable, the City Council:

Attached is an order requesting an appropriation of \$20,000 to the Grant Fund Human Services Department Other Ordinary Maintenance account. The funds were raised from the FY89 "Kick in for Kids" road race and will be used to cover incurred actual race expenses with the remaining balance to offset child care expenses. The child care programs consist of six after school programs, three pre-school programs and one day care program. The race funds assist us in maintaining tuition rates for parents at a minimum and to allow children from needy homes to participate.
