

Be it ordained by the City Council of the City of Cambridge as follows:

Chapter 8.28 of the Cambridge Municipal Code is hereby amended by adding the following new §8.28.045 (smoking in playgrounds prohibited):

8.28.045 Smoking in playgrounds prohibited.

No person shall smoke in any public playground in the City. For purposes of this section, "public playground" means an outdoor area, open to the public, which is set aside for play and has equipment such as, but not limited to, seesaws and swings.



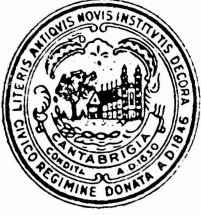


