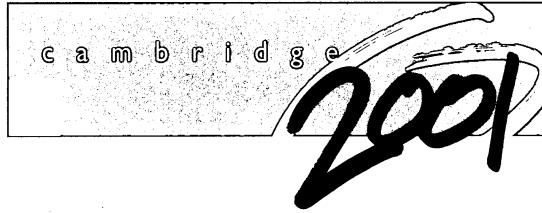

To the Honorable, the City Council:

I am hereby requesting an FY02 appropriation totaling \$885,000 in the Community Development Public Investment Fund Extraordinary Expenditures Account \$796,500 and to the Grant Fund in the amount of \$88,500 to the Salary and Wages Account (\$79,650), Other Ordinary Maintenance Account (\$6,850), and Travel and Training Account (\$2,000). The U.S. Department of Housing and Urban Development (HUD) has awarded funds through its HOME program to provide funds for affordable housing. Funds will be used for acquisition, rehabilitation and construction of affordable housing units, for the salary and wages of the HOME Program Coordinator and an intern, for administrative expenses and for staff education and training.
