Petition of Boston Edison Company for approval by the Department of Public Utilities of the issuance and sale by the Company at not less than par, principal amount not exceeding \$25,000,000, Series I Bonds, payable at periods of more than five years after the date thereof; and approval of the rate of interest said bonds shall bear; said issuance of bonds to be secured by a first mortgage of the franchise and property now owned or hereafter acquired by the Company; the proceeds of such issue and sale to be used for the purpose of financing and funding expenditures for extensions, additions and improvements to the Company's plant and properties and the payment of obligations of the Company representing such expenditures.

the Commission of the Department of Public Utilities will hold a public hearing
