CPC Legal Director Jeff Wolf testified before the joint House-Senate Committee on the Judiciary in support of **An Act Protecting Children from Domestic Violence in Custody and Visitation Proceedings**. If enacted, this legislation would require courts to consider the effects of any domestic violence when creating custody and visitation orders.

CPC is collaborating with five agencies on the **Cambridge Emergency Rent Control Eviction Project** to help low and moderate income tenants cope with the demise of rent control.

Counseling Does Make a Difference

Robin came to **CPC** desperate for help when she left her abusive husband after ten years of marriage. The abuse included holding a gun to her head. During the first year of counseling she returned to him twice after he threatened to hurt their three children. In her third year, Robin added group counseling. The support and gentle confrontation she received from other group members combined with her increasing insights in individual counseling finally gave her the courage and self-esteem to proceed safely to a divorce and a job.
