Enclosed you will find a copy of a petition from the Vietnam Dining House requesting permission for a projecting sign at the premises numbered 460 Mass. Avenue, dated December 22, 1983. The City Council, at its meeting of January 9, 1984 was in receipt of said petition, and on motion of Councillor Graham, Tabled it, with the request that this office notify the petitioner of the Council's action and request the petitioner's views as to the feasibility of a flush sign rather than a projecting sign. No response was received from the petitioner, and the sign petition remained on the "Table" until the Council meeting of Monday, September 10th, at which time Councillor Duehay moved it from the Table and moved that it be referred to the new sign processing procedure.

Would you please be so kind as to review the enclosed petition and advise as to whether it meets with the appropriate standards and/or regulations for a sign in conformity with the City's new sign ordinance.

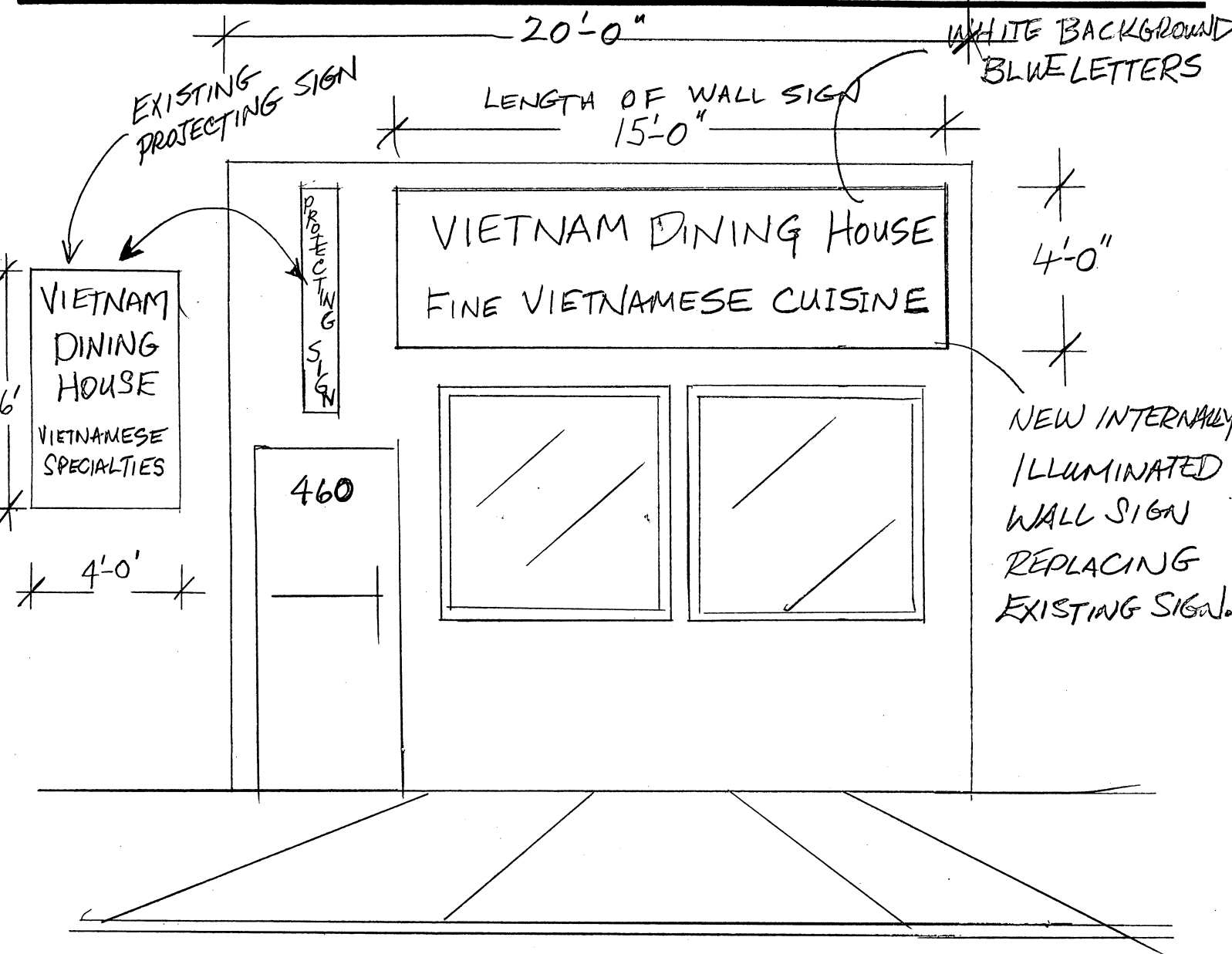

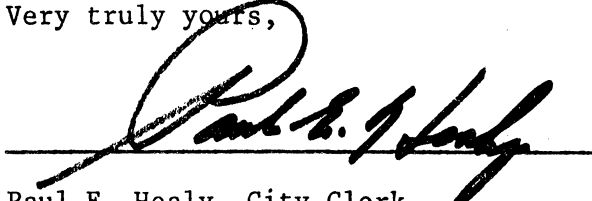
