The aforesaid plans are on file in the Assessors' Office, City Hall, Cambridge, Mass.

The grade of said sidewalks is to conform, substantially, to the grade of the street, and all matters not herein particularly specified in regard to the construction of said sidewalks are to be determined by the Commissioner of Public Works, subject to the approval and under the direction of the City Manager.

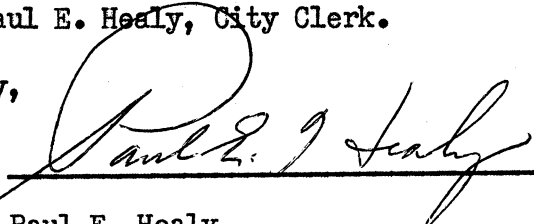
