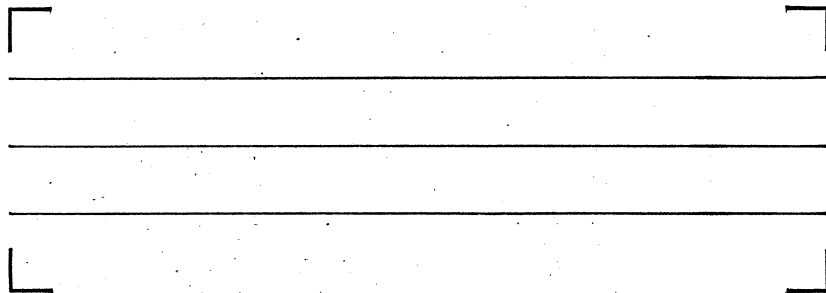

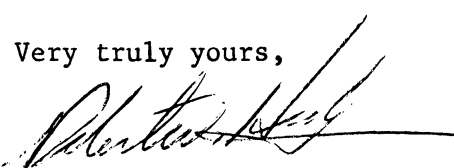
With reference to your recent request for permission to conduct a sale of merchandise in front of your store at 35 Brattle Street, permission is herewith granted subject to the following conditions -
