

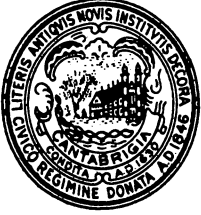



The following transfer of \$2,000 from the Community Development Department's Salary and Wage account to the Other Ordinary Maintenance account is needed to cover the costs of two planners working on special projects.
