To The Honorable, The City Council:

I am hereby requesting the appropriation of \$149,980.00 into the Grant Fund of the Department of Human Services Salaries and Wages Account (\$81,305.00), Other Ordinary Maintenance Account (\$66,175.00) and Travel and Training Account (\$2,500.00) from the Massachusetts Department of Education. The Kid's Council has received a grant for a center for families which will provide broad based support services to neighborhood families. This will be a pilot project to be conducted in the North Cambridge neighborhood. The funds are received from the Department of Education and are matched by \$51,000.00 of City funds of which \$17,000.00 is committed by the School Department, \$17,000.00 from the Cambridge Hospital and \$17,000.00 from the Department of Human Services Programs. The funds will be used to staff the center, purchase necessary equipment and support services and provide for occupancy expenses.
