Pursuant to the provisions of the order passed by the City Council on March 28, 1973, in the adoption of the 1973-1974 City Budget, I do hereby request the transfer of \$1,200.00 to D-16, Supplies not otherwise coded for the following reasons: *RS-92-572*

Vandalism has been a major problem at all libraries in Cambridge: The Field Branch, the Main Library and North Cambridge Branch have had severe glass breakages and destruction -- all requiring immediate repair.

It's a wasteful use of public funds and many efforts have been made to solve the problems. Air conditioning and heating breakdowns also have factors for the deficit in this account.

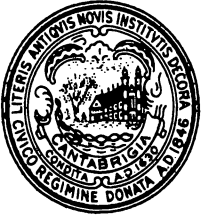


