IN CITY COUNCIL

July 26, 1999

WHEREAS: A petition was received from Pierre Alesy, doing businesses as Air Shuttle, 717 Broadway Everett, MA 02149 on December 18, 1998 for a jitney license; and

WHEREAS: A hearing was held by the License Commission on January 26, 1999; and

WHEREAS: Because the jitney application was incomplete, a subsequent hearing was held by the License Commission on March 16, 1999; and

WHEREAS: On April 29, 1999 the License Commission recommended the approval of the jitney license and forwarded the petition to the City Manager; and

WHEREAS: The City Manager forwarded the petition to the City Council for their approval on May 17, 1999; and

WHEREAS: The City Council referred the petition back to the License Commission for reconsideration of their recommendation; and

WHEREAS: On June 15, 1999 the License Commission forwarded the petition back to the City Manager with no change in the application; and

WHEREAS: The City Manager forwarded the jitney application to the City Council at its meeting of July 26, 1999; now therefore be it

ORDERED: That the City Council hereby accepts the recommendations of the License Commission to grant a jitney license to Pierre Alesy, doing business as Air Shuttle, 717 Broadway, Everett, MA 02149 under the provisions of Chapter 159A of the Massachusetts General Laws for the operation of a jitney service over the following public ways in the City of Cambridge:

1. From Sheraton Commander Hotel to Logan Airport: take Garden Street, right on Massachusetts Avenue, right on Brattle Street, right on Mount Auburn Street, left on University Drive, left on Bennett Street, stop at the Charles Hotel, straight to Eliot Street, right on John F. Kennedy Street, left on Memorial Drive, left on Amesbury street, stop at Hyatt Regency Hotel, right on Vassar Street, right on Main Street, right on Ames Street, right on Broadway, stop at Marriott Hotel, left on Third Street, right on Binney Street, left on Edwin H. Land Boulevard, stop at Royal Sonesta Hotel, right on Msgr. O'Brien Highway, straight to 93 South, Exit 24, Callahan Tunnel to Logan Airport.

2. From Logan Airport to Cambridge: take Sumner tunnel to 93 North, exit 26/Cambridge, take Storrow Drive, right on Msgr. O'Brien Highway, left on Edwin Land Boulevard, left, stop at Royal Sonesta Hotel, back to Edwin H. Land Boulevard, right on Main Street, straight to Broadway, left on Ames Street, left on Main Street, stop at Marriott Hotel, continue to Main Street, right on Memorial Drive, right on John F. Kennedy Street, straight on Massachusetts Avenue, right on Garden Street, left on Chauncy Street, left on Concord Avenue, right on Garden Street, stop at Sheraton Hotel; and be it further

ORDERED: The applicant has received approval from the Metropolitan District Commission for two vans with operation hours of Monday through Saturday 7:00 a.m. to 7:00 p.m.; and be it further

ORDERED: That the City Council reserves the right to revoke the license granted.

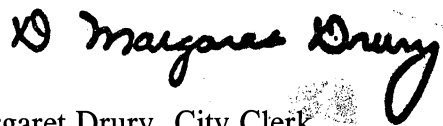

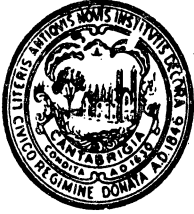

This is to advise you that on April 29, 1999, the License Commission voted 3-0 to recommend to the City Manager approval of the application of Pierre Alesy, d/b/a Air Shuttle, for a jitney license to be exercised on the following route.

From Sheraton Commander Hotel to Logan Airport: Take Garden Street, right on Massachusetts Avenue, right on Brattle Street, right on Mount Auburn Street, left on University Drive, left on Bennett Street, stop at the Charles Hotel, straight to Eliot Street, right on John F. Kennedy Street, left on Memorial Drive, left on Amesbury Street, stop at Hyatt Regency Hotel, right on Vassar Street, right on Main Street, right on Ames street, right on Broadway, stop at Marriott Hotel, left on Third Street, right on Binney Street, left on Edwin H. Land Boulevard, stop at Royal Sonesta Hotel, right on Msgr. O'Brien Highway, straight to 93 South, Exit 24, Callahan Tunnel to Logan Airport.

From Logan Airport to Cambridge: take Sumner tunnel to 93 North, exit 26/Cambridge, take Storrow Drive, right on Msgr. O'Brien Highway, left on Edwin Land Boulevard, left, stop at Royal Sonesta Hotel, back to Edwin H. Land Boulevard, right on Main Street, straight to Broadway, left on Ames Street, left on Main Street, stop at Marriott Hotel, continue to Main Street, right on Memorial Drive, right on John F. Kennedy Street, straight on Massachusetts Avenue, right on Garden Street, left on Chauncy Street, left on Concord Avenue, right on Garden Street, stop at Sheraton Hotel.

The applicant has received M.D.C. approval for two vans and operation hours of Monday through Saturday, 7:00 a.m. to 7:00 p.m.
