To The Honorable, The City Council:

I am hereby requesting an appropriation of \$103,789.00 in the Grant Fund of the Human Services Other Ordinary Maintenance Account. The Massachusetts Department of Housing and Community Development has awarded emergency Federal funds to the Fuel Assistance Program in order to provide cooling assistance to low income households. Benefits will be available to those households eligible for Fuel Assistance in the form of a onetime payment toward electricity. A payment of \$75 will be made to non-subsidized households while subsidized households will receive \$25.
