

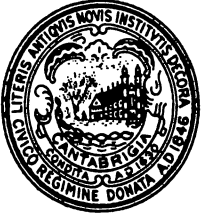


To the Honorable, the City Council:

Attached please find for your review and action an order requesting the acceptance and appropriation of a grant in the amount of \$131,355 from the State Department of Education to the grant fund of the Department of Human Service Programs.
