To The Honorable, The City Council:

I am hereby requesting the appropriation of \$205,000.00 in the General Fund of the Public Works Department Other Ordinary Maintenance Account from Free Cash. This is the second appropriation for additional funds to cover snow removal. Since the first appropriation of \$754,000.00 for non-salary expenses, final bills for contractors, road salt, sand, calcium chloride and equipment repair used to remove snow this winter have been received. The total amount appropriated for non-salary snow removal expenses for FY96 is \$886,000.00. This appropriation will bring the snow allocation to \$1,091,000.00.
