IN CITY COUNCIL

January 20, 1975

ORDERED:

That a license be and hereby is granted to Vocell Bus Lines of Pinchurst, Massachusetts under the provision of Chapter 159A for the operation of motor vehicles to transport students from Lesley College to Andover Public Schools for the purpose of student teaching on the following streets in the City of Cambridge:-

On Mooney Street between Smith Place and 52 Mooney Street to Right on Smith Place between Concord Avenue and Mooney Street to Left on Concord Avenue between Chavney Street and Smith Place to Left on Chavney Street between Massachusetts Avenue and Concord Avenue to Left on Massachusetts Avenue between Mollen Street and Chauncy Street to Right on Mollen Street between Oxford Street between Cambridge - Somerville Line and Mollen Street.

This license is granted subject to the condition that student passengers will be picked up and discharged at the Lesley College area and no other stops for passengers will be made within the limits of the City of Cambridge.

This petition for a license is granted subject to the approval of the City Manager.

Provided further that the petitioner provide the City Clerk with a schedule of the coaches to be used and a schedule of the departure and arrival times for the above described route.
