The Central Artery/Tunnel Project will depress and widen the existing Central Artery (I-93), an existing multi-lane limited access highway from south of the interchange of the Southeast Expressway (I-93) with the Massachusetts Turnpike (I-90) to an interchange with U.S. Route 1 in Charlestown, and extend I-90 northward terminus at I-93 to a new terminus at Logan Airport. The purpose of the project is to improve north-south traffic through Boston using the Central Artery/Tunnel. The project also includes: (1A); improve cross-harbor access to and from Logan Airport; (1B); improve seaport access from regional highways; and (1C); improve truck traffic on regional streets.
