WHEREAS:

Thomas J. Mahoney, a former employee of the Fire Department of the City of Cambridge, entered the serve of the Fire Department on April 6, 1930 and was pensioned on February 4, 1962 and died on December 1, 1972, having served not less than thirty-one years, and

WHEREAS:

At the time of his death said employee had no rights to elect that benefits be paid to his survivor, said employee leaves as his survivor, his widow, Georgia Mahoney, who has not remarried and is not receiving any retirement allowance or pension under the provisions of any general or special law, therefore be it

ORDERED:

That, under the provisions of Section 61A, Sub-section A and Section 94 of Chapter 32 of the General Laws, Tercentenary Edition and amendments thereto, that in order to promote the public good, and in consideration of the long and meritorious service performed by Thomas J. Mahoney, an annuity be granted to Mrs. Georgia Mahoney, widow of Thomas J. Mahoney, of \$1680.00 per year.
