ORDERED:

That, in accordance with the provisions of an ordinance relative to placing and maintaining signs, the Commissioner of Public Works be and hereby is authorized to grant a permit to the Harvard University Museums of Natural History for the erection of a streetlight banner commemorating their 350th anniversary; said streetlight banner to hang from the Oxford Street light in front of the Museum complex from September 1st through September 30th, 1986.

Provided that, before erecting the above named banner, the petitioner shall obtain a permit from the Inspectional Services Department and file with the City Clerk a satisfactory bond in the sum of Two Thousand (\$2,000.) Dollars, conditioned to save harmless the City of Cambridge from all claims for damages arising from the construction, maintenance and use of said banner.

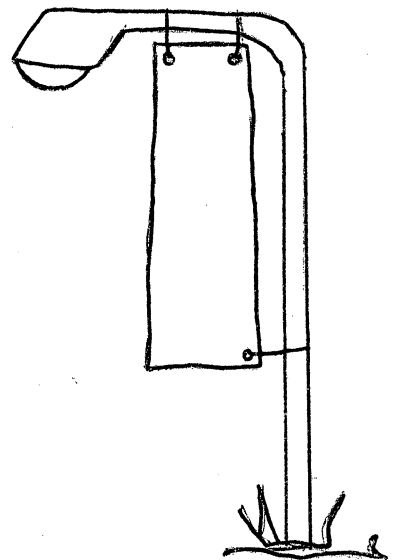
