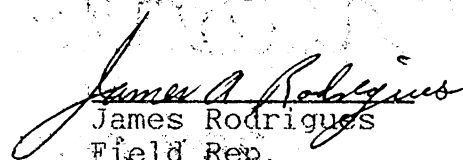
Mr. Healy:

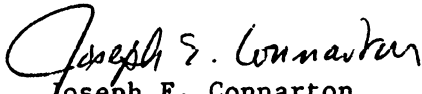
