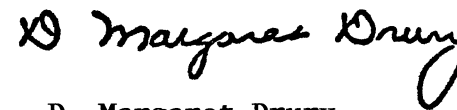

To The Honorable, The City Council:

I am hereby requesting the appropriation of \$47,000 from Free Cash to the Election Commission Other Ordinary Maintenance Account to provide funds to cover additional costs incurred when the Election Commission was required to mail information to voters concerning the ballot question on a nuclear weapons convention (\$20,500) and the difference between the amount budgeted for temporary personnel for both the Municipal Election in November and the Presidential Primary in March and the amount that they will be paid due to the approval of the "Living Wage" Ordinance (\$26,500).
