

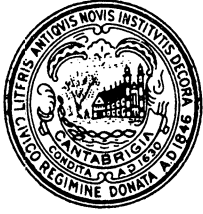

Subject Dept. of Manpower Grant

The City of Cambridge, Department of Human Service Programs, has recently been awarded a grant from the Massachusetts Department of Manpower Development to expand after-school child care through our Community Schools program. Specifically, we will be expanding and/or initiating after-school programs at Morse, Longfellow, Fletcher, and Fitzgerald for 45 children. Twenty-three of the slots will be set aside for the children of participants in Cambridge CETA training and employment programs. The remaining slots will be available on a sliding fee basis to Cambridge neighborhood residents..

I am hereby requesting that \$63,523 be appropriated to cover the cost of the program. Forty-five thousand dollars will be received from the Department of Manpower Development and \$18,523 will be collected in fees from the four child care programs to cover the total operating cost of the program.


