The Principal of this Degree is PATRIOTISM, the first three being, CHARITY, UNITY and FRATERNITY.

Bishop Cheverus Assembly is made up of some 31 Councils throughout the Boston and Vicinity area, mainly, Cambridge, Belmont, Chelsea, Revere, Winthrop, Brighton just to name a few. Our membership now stands at 845 members.

Some of our Distinguished members of our Assembly was the First Catholic ever to become President of the United States, the late Sir Knight, The Honorable, President, John Fitzgerald Kennedy, Sir Knight, the late Speaker of the House, John W. McCormack, The Former Speaker of the House, Sir Knight, Thomas P. (TIP) O'Neill, Jr., all of Boston's Cardinal Archbishops, Bishops and Priests.

Our Assembly was instituted on OCTOBER 17, 1910, we celebrate our 80th Anniversary which will open on Sunday, September 30th with a Televised MASS to be aired on Channel 7, WHDH at 8:30 a.m., Father, Frank McFarland will be celebrant of the T.V. MASS. We will close the celebration with our 80th Anniversary Banquet which will be held at the Immaculate Conception School Hall in North Cambridge.

Bishop Cheverus was the First Bishop of Boston, who came to the United States from Paris France with Father Matignon of which the High School in North Cambridge bears his name. Together they led this great Archdiocese of ours.
