WHEREAS:

In the judgement of this City Council public convenience requires that edgestones be set in certain public ways, as hereinafter stated, and it is therefore

ORDERED:

That edgestones be set, as hereinafter stated, to wit, in front of the following premises:

No. 68 Francis Avenue - supposed owners Nancy L. & Edwin W. Salzman
Assessors' Block Number 147, Lot Number 33.

The aforesaid plans are on file in the Assessor's Office, City Hall, Cambridge, Massachusetts.

The grade of said edgestones is to conform, substantially, to the grade of the street, and all matters not herein particularly specified in regard to the setting of said edgestones are to be determined by the Commissioner of Public Works, subject to the approval and under the direction of the City Manager.

The said Commissioner of Public Works is hereby authorized and instructed to set said edgestones, and in the manner aforesaid, and to report to this City Council, after completion of the work, the cost thereof, and the assessment of one-half the cost shall be made upon the abutting estates.

A copy of this order, certified by the City Clerk, shall be recorded forthwith in the Middlesex South District Registry of Deeds.
