This acknowledges your inquiry of October 12, calling our attention to correspondence you received from Mr. Paul E. Healy, Temporary City Clerk of Cambridge, Massachusetts, concerning the status of Massachusetts under our recently announced program to provide additional manpower training assistance to areas of high unemployment.

As the enclosed statement indicates, this program was extended to include Massachusetts on September 24. Specific participating areas in the State are being selected in cooperation with the Office of the Governor, from among those communities which have the highest number or rate of unemployment in the State, or have registered the most serious employment cutbacks during the past year.
