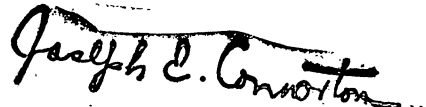

Attached is an order requesting the appropriation of \$113,240.00 from the Sale of City Land account to the Public Investment Extraordinary Expenditure account to provide funds for the completion of Phase III of the Lechmere Canal Park.
