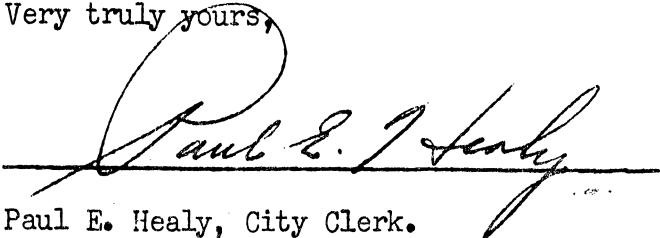

City of Cambridge:
