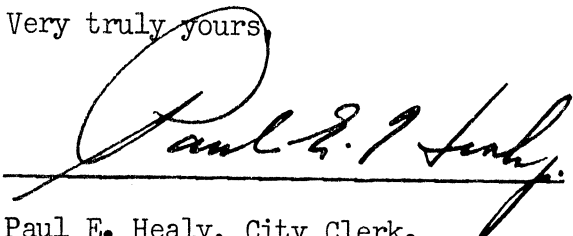

I then contacted Paul Healy and told him what I had learned. He is presently investigating the matter.

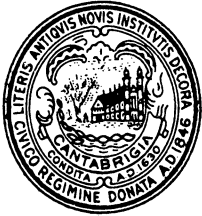
The License Commission has no authority to issue a license to Winston Transportation so cannot suspend its operation.
