The aforesaid plans are on file in the office of the Assessors, City Hall, Cambridge, Mass.

The grade of said edgestones is to conform, substantially, with the grade of the street, and all matters not herein particularly specified in regard to the setting of said edgestones are to be determined by the Commissioner of Public Works subject to the approval and under the direction of the City Manager.

And the Commissioner of Public Works is hereby authorized and instructed to set said edgestones, and in the manner aforesaid and to report to this City Council after the completion of the work, the cost thereof and the assessment of one-half the cost shall be made upon the abutting estates.
