

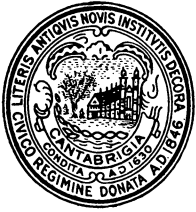

I hereby request an appropriation in the amount of \$177.43 to reimburse Michael Souza, an employee of the Public Works Department for damages in this amount.

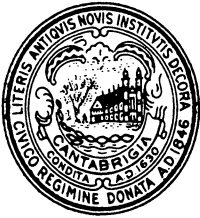
The Law Department, under the provisions of General Laws, Chapter 41, Section 100-A, defended an action against Michael Souza in which there was a judgment of \$177.43.
