Please be advised that your petition requesting a driveway at the premises numbered 3 Suffolk Street has been denied due to the fact that said petition was disapproved by the Building Department.

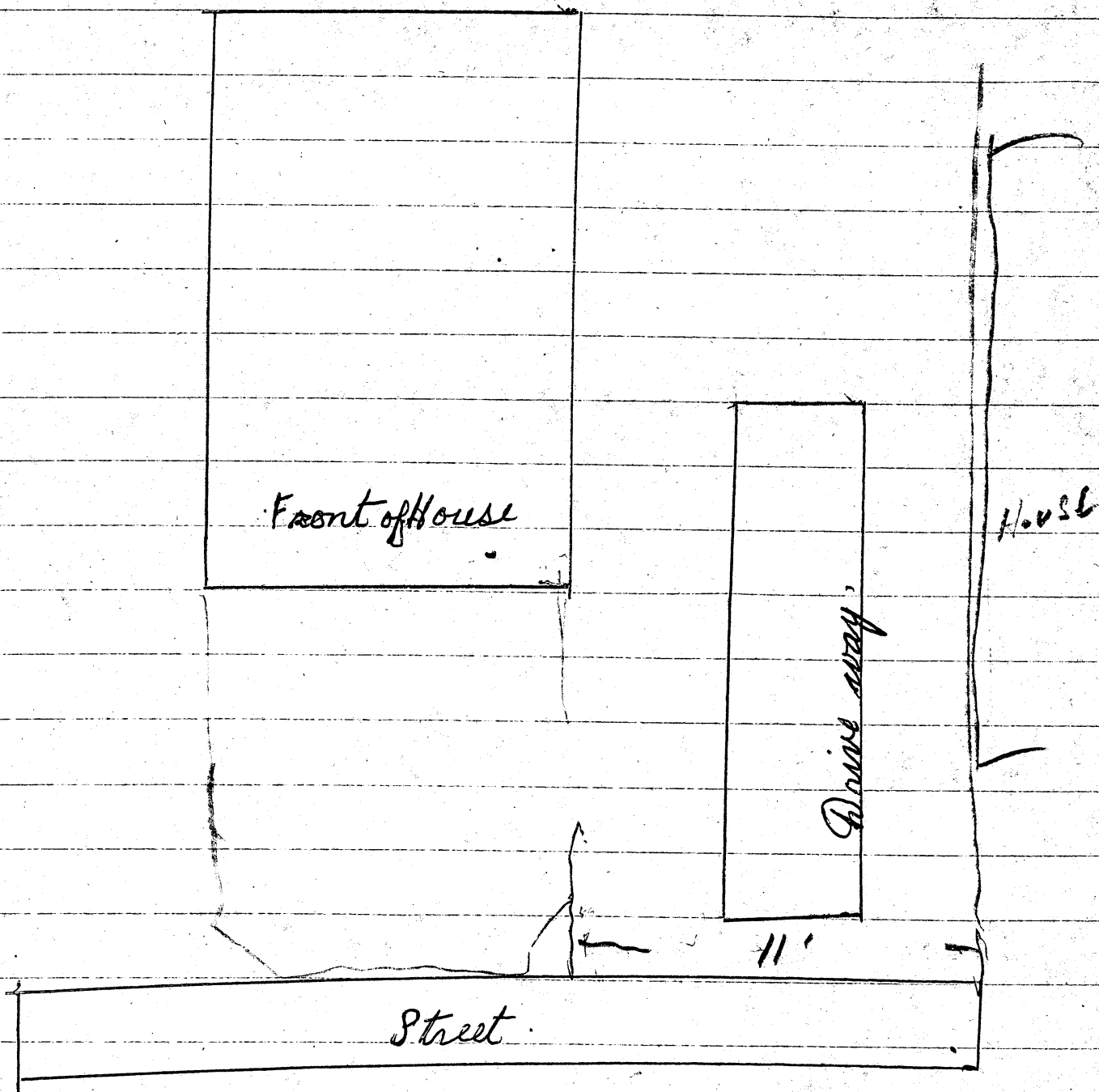
