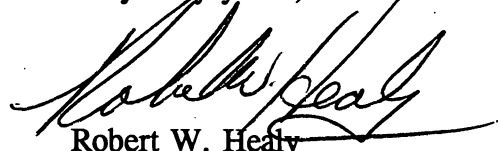

Attached is an order requesting the appropriation of \$22,306.00 in the Grant Fund from the Commonwealth of Massachusetts, Executive Office of Elder Affairs to the Human Services Department Salary & Wages Account \$21,356.00 and Travel & Training Account \$950.00. The Council on Aging receives, annually, a Formula Grant from the State to assist the Council with its programming.
