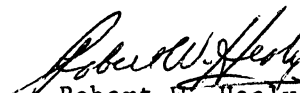
To the Honorable, the City Council:

Attached please find for your review and action an order requesting the acceptance and appropriation of a grant in the amount of \$28,386.00 from the Cambridge Housing Authority to the Department of Human Service Programs Grant Fund. The appropriation will be allocated as follows: Salaries and Wages, \$19,529.00 and Other Ordinary Maintenance, \$8,857.00.

This grant will fund an employment and training readiness service from October 1, 1985 to June 30, 1986. This program, targeted for residents of Roosevelt Towers, Newtowne Court, and Washington Elms, will include workshops in job applications, interview and resume skills, and placement in an education or training program or a job. This program will be conducted by the Community Learning Center.
