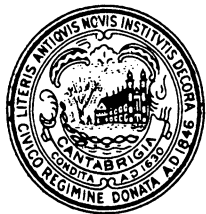

It is respectfully requested that the following transfer in the General Fund of the City of Cambridge be authorized -


