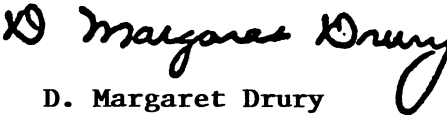

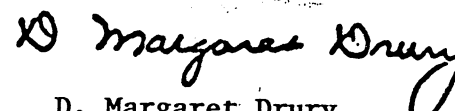

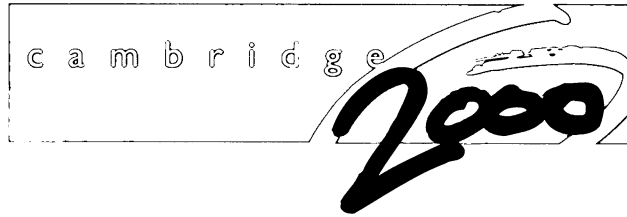

To The Honorable, The City Council:

I am hereby requesting the appropriation of a grant from the Massachusetts Department of Education for \$30,240 to the Grant Fund Salaries and Wages account (\$29,964) and Other Ordinary Maintenance account (\$276) to provide funds to enable the Community Learning Center to provide ESL classes for employees of several Harvard Square workplaces. These funds will cover a portion of the salaries of one full-time teacher, one full-time support staff position, and one part-time instructor as well as program expenses.
