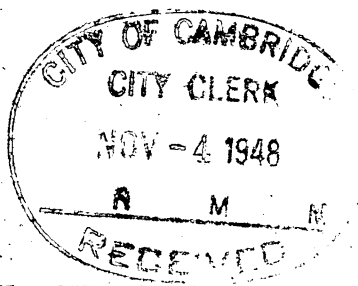

TO THE HONORABLE MA YOR AND CITY COUNCIL OF  
THE CITY OF CAMBRIDGE:

We the undersigned residents and/or property owners on Dale Street, Cambridge disapprove and oppose the contemplated action of the Council to change the name of Dale Street to "Corporal Burns Road" on the basis of the following reasons:

(1) In general we don't approve of the very idea of changing names of streets as a means of commemorating our war dead. This policy as a whole lacks merit, causes strained feelings, confusion and unnecessary inconveniences.

(2) The young man in whose honor the contemplated change of names is being made never lived on Dale Street and his parents have been living on Dale Street at most for the past four years approximately.
