I am hereby requesting the appropriation of \$1,189,354.00 in the Grant Fund of the Department of Human Services Salaries and Wages Account (\$59,468.00), and Other Ordinary Maintenance Account (\$1,129,886.00) from The Department of Housing and Urban Development. This grant will fund a three year Supportive Housing Program which will start December 15, 1995 and continue through December 14, 1998. The purpose of this grant is to provide supportive housing related services to persons at risk of homelessness. A majority of the funds will be subcontracted to the following agencies: CASPAR, CASCAP, Shelter Inc. and Bread & Jams.
