His other assignments were as follows:

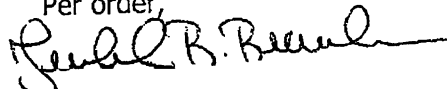
December 3, 1979	Deputy Chiefs' Aide, Group 2
