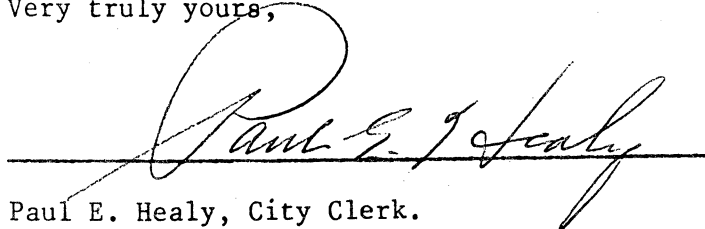
Dear Ms. Burton:
