To The Honorable, The City Council:

Attached is an order requesting the appropriation of \$17,000.00 in the Grant Fund from both the Boston and Cambridge Foundations through Friends of the Community Learning Center, Inc. to the Human Services Department Salary & Wages Account. The Community Learning Center Division will hire a full time coordinator to develop a network of English as a Second Language (ESL) Program sites throughout the City. The coordinator will also provide training, student assessment, program coordination and other support services to expand ESL availability. The total cost of the coordinator plus other program expenses is estimated at \$43,330.00, of which the remaining \$26,330.00 will come from the City's general fund.
