To The Honorable, The City Council:

Attached is an order requesting the appropriation of a grant fund for \$12,479.00, from the Federal Emergency Management Agency (FEMA) to the Human Services Ordinary Maintenance Account to provide funds for food and shelter and supplementing current available emergency services. \$9,000.00 of these funds will be subcontracted to the YMCA for 6 emergency rooms from May 15 to September 30, 1990. \$3,479.00 will be allocated to the Fuel Assistance Program to augment available resources.
