
Dear Mr. Corcoran:

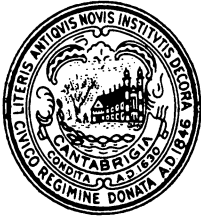
We have available in B-44, Travel Outside the State, a total of \$129.00


