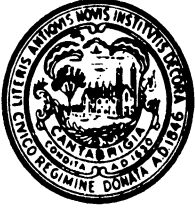

To The Honorable, The City Council:

I am hereby requesting an appropriation of \$2,704.00 in the Grant Fund of the Department of Human Services Programs' Workforce Development Divisions' Salary and Wages Account (\$700.00) and Other Ordinary Maintenance Account (\$2,004.00) from the Massachusetts Department of Education. Funds were awarded for a Needs Analysis, which will determine the need for Adult Basic Education and/or English as a Second Language services for retail and food service workers in the Harvard Square area. This analysis will be conducted with the support of the Harvard Square Business Association. If the analysis demonstrates sufficient need, a plan to implement an education program will be developed and submitted to the State to secure additional funding for a program.
