Please be advised that the City Council at its August 2, 1982 meeting has on motion of Councillor David Sullivan, referred back to your attention Agenda Item Number Seven.

In connection with Agenda Item Number Seven, the same being a proposed graduated liquor license fee schedule based on volume and seating capacity, which is not permitted under existing law, Councillor David Sullivan has requested that the City Solicitor draft legislation for the consideration of the Great and General Court. Said legislation to provide for a new fee schedule of graduated liquor license fees based on volume and seating capacity.

Councillor Duehay has further requested that the License Commission provide the City Council with the rationale behind the fee schedule adopted and considering a more reasonable approach to charitable organizations and further to consider the problem of institutions which operate on one license and which have more than one area concerned with the distribution of alcoholic spirits.
